Resignation Terms & Conditions

The applicant may resign from the club, by giving a 30 day written notice. All accrued dues and other charges for which applicant is liable are due upon the effective date of the resignation. Applicant agrees and understands that they are responsible for all assessments and fees up to the date of written resignation. The initiation fee is a one-time, non-refundable charge. If a member resigns, they will be subject to another initiation fee if they choose to re-join the club. Applicant agrees and understands that they are responsible for all assessments and fees up to the date of written resignation.

APPLICANT INITIALS _____

Applicant agrees that in the event of a corporate reorganization or personal divorce, this membership is not divisible and this membership shall be allocated by agreement of all claimants, or in the absence of agreement, by court order. Such allocations are subject to the sole approval of Sterling Country Club. The successor to the membership shall execute all necessary papers and pay all allocation fees required by the Club. Membership does not confer any ownership of the club's property or assets.

APPLICANT INITIALS _____

Payment of account is due the 1st of the month. Applicant agrees that the club may assess a late charge for past due accounts. Payment on delinquent accounts applies first to reduce late charges and accrued dues, then to food and beverage charges, then to any other charges. Dues and other club charges are considered luxuries under all applicable laws. Applicant agrees to pay all reasonable attorney fees, court fees, investigator fees and any associated costs in the event his account is turned over for collection.

APPLICANT INITIALS _____

Members may request the "inactive status" once in the lifetime of their golf membership. If approved, the inactive status is a mandatory one year freeze of the membership, with a maximum of 36 months. If the inactive status remains for over 36 months, it will be subjected to termination. Any additional inactive requests are at the discretion of Sterling Golf Management.
